- 3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the, MOH & FW, Government of India.
- 4. The State shall ensure that 25% of its share based on release of funds by Government of India is credited to the appropriate Accounts.
- 5. The State shall ensure completion of Delegation of Administrative and Financial Fewers during the current Spancial year and funding of Integrated Disease Surveillance frogrammes will be based on clear delegation as per earlier directions.
- 6. The State shall follow all the financial management systems under Integrated Disease Surveillance Project and shall submit within six months of closing of transcial year Statutory Audit Emports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs / SOEs and Statement of Fund Position showing unspent balances, funds released as advances, inverest earned on unspent balance.
- 7. The remuneration of contractual staff may be paid, provided a provision for the same had been made in the State PIF and approved by the NPCC for the current financial year.

- 8. The fund to the Assam State has been released from Budget Estimate (Domestic Budget Component) for the financial year 2014-15 of MOH&FW, Government of India. Releases made under this Sanction Order are only in respect of Programmes/ Schemes/ activities to institutions or organisations set up as Autonomous organizations under a specific statue or as a Society registered under the Societies Registration Act, 1860 or Indian Trusts Act, 1882 or other statutes as per Rule 206 (a) of GFR 2005, for which.
